I/We agree to pay any bank charges relating to this debit order instruction. I/We understand that this agreement may not be cancelled within the first 3 (three) months of this agreement, thereafter, this authority may be cancelled by me/us by giving you 30 (thirty) calendar days' notice in writing, sent by prepaid registered post, but I/we understand that I/we shall not be entitled to any refund of amounts which you have withdrawn while this authority was in force, if such amounts were legally owing to you. Receipt of this instruction by you shall be regarded as receipt thereof by my/our bank (whichever it is or will be). A R30 administration fee will be levied on all unpaid debit orders.
